RULES & REGULATIONS OF 2021 SHOWCASE

PLEASE READ CAREFULLY

EXHIBITOR'S & ENTRY RULES

1. All entries in **EACH** competition must be contained in a tote or other suitable container with exhibitor's name clearly marked on outside of container in large letters.
2. Each container/tote must include your entry form filled out and signed, as well as your \$5.00 membership fee if applicable.
3. Each item in your container/tote must have an entry tag properly completed. Tags may be picked up at the Fairboard office Wednesdays' in August 2021, or you can email your request to kingstonfallfair@gmail.com along with your mailing address prior to Sept 1, 2021 and we will mail you the tags. After Sept. 1st you must pick up the tags.
4. **There will be four (4) drop off locations, one for each competition. You must wear a mask and observe Social Distancing and remain in compliance with KFLA Health Unit Rules and Regulations.**
5. Items will be judged, photographed and repacked in your container/tote, together with any ribbons and or prize money if applicable. Prize money will be paid in cash.
6. You must pick up your container/tote the same day, Sept. 18th between 4p.m. and 6p.m. at the same location that you dropped it off.
7. Exhibitors must read rules and those stated in the individual competitions in order to note any additions and/or exceptions.
8. All exhibitors must be a resident of The Province of Ontario, unless otherwise stated.
9. All exhibitors must be a current member of the Kingston & District Agricultural Society for a fee of \$5.00 per adult. Youth are free this year.
10. All exhibits must be bonafide property of the exhibitor. Farm produce is to be the growth of the current year and exhibited by the grower.
11. Unless otherwise noted, Exhibitors are restricted to one entry per section.
12. In the absence of competition in any section, or if the stock/article or display exhibited are of inferior quality, the Judges will award only such premiums as they think the article deserves. Judges please note.
13. No exhibit will be given a prize unless it is deemed worthy.

14. Any protest against the decision of the Judge, or any exhibit, must be made and delivered to the secretary in writing within 24 hours of the close of the specific event; stating the nature of the protest and signed by the complainant. A \$25.00 non-refundable fee must accompany the original complaint.
15. Exhibitors are requested to obtain an exhibitor's number and exhibitor tags from the Fair Board Office upon submission of the entry form. The entry form must be completed using the wording of the prize book. An improperly completed entry form could disqualify an entry. No prize money will be paid unless a fully completed entry form has been submitted to the office. Exhibitors must make their own choice as to class and section in which they enter their article or exhibit.
16. Any person attempting to interfere with or influence a Judge or who shall at any time use abusive language to any director or judge or use fraud, deception, or dishonest practices, shall forfeit any premium to which he/she might otherwise be entitled and shall be excluded from exhibiting.
17. Any Exhibitor or attendant refusing to comply with any of the Agricultural Society's rules will forfeit entry fees and the right to compete to receive any premium.

LIABILITY, INSURANCE & WAIVERS

18. It shall be a condition of entry that the Agricultural Society will not be liable for loss to an exhibitor occasioned by fire, accident, condition of structure, or the negligence of other exhibitors or officials or otherwise howsoever.
19. All Exhibitors are required to sign an entry form which includes a Hold Harmless Waiver.

PRIZE MONEY

20. All entrants must be in good standing with KDAS.
21. Anyone may become a member of this society by paying a fee of \$5.00 per adult. Youth are free this year.

ENTRANCE & EXIT GATES

York Street entrance: Vehicle Entrance Only - Drop Off and Pick up Gate.
Nelson Street Exit: All traffic exits via Nelson Street Gate
Temporary Parking only while dropping off and/ or picking up.
